

Making an educational textbook inaccessible to those with disabilities is not acceptable.

Terrible textbook. Terrible HW problems at the end of the chapter and reads like the author is used to writing a math textbook. However, like most of you reading this, you are probably required to get it.Advice? RENT IT! Do not waste any money on buying it. You will not reference it in the future.

The layout is very easy on the eyes and the concepts are pretty easy to follow. I kinda wish I would have reviewed Calculus prior to reading some of this though.

This is a terrible excuse for a textbook. There are a lot of holes in the instruction. The demonstration problems skip steps, so it is easy to get lost. They switch variables around in the same chapter. Very disorganized and hard to learn from. Should be \$10.

This book is excellent. It is well organized by chapter and gives plenty of examples. While it does shy away from doing any non-basic calculus, it is very math and model-centric, just as economics should be. This book is clearly written for someone who already has a thorough understanding of economics. Unfortunately, my professor selected it as the text and I just had to deal with it. It can be read, you will just need patience.

The book gives good examples, however it takes the author a long time to get to his point with a few of the concepts.
