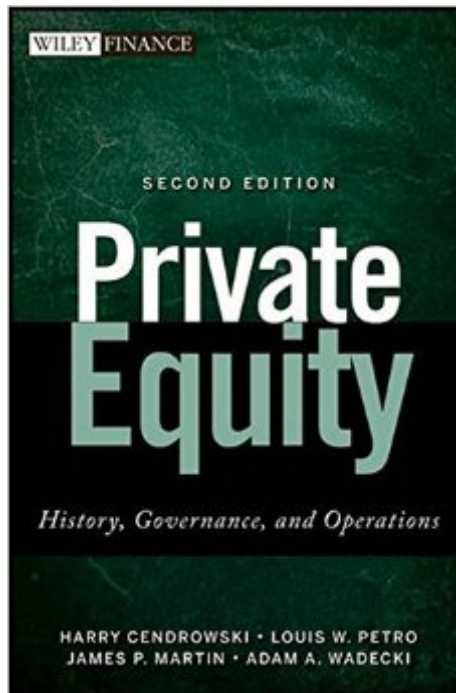

importance of internal control aspects and how these can help deliver higher investment returns. The author's other book on Controls [...] was equally helpful to me. The third section "Operations" is OK - personally, I am not heavy into operations and hence I was not able to extract much here. Overall, a good read and will make an excellent addition to the bookshelf of PE practitioners - seasoned and newbies alike.
